TERMS AND CONDITIONS

All prices are quoted in U.S. dollars. They are based on tariffs, airfares, accommodation rates, and rates of exchange quoted to *Anderson Tours LLC* at the time of publication. These prices are expected to be in effect at the time of departure; however, prices are subject to change without notice. *Anderson Tours* will make every effort to avoid price increases; however, any changes in price made by the airlines, hotels, vendors, operators, etc. with which *Anderson Tours* has made arrangements, may be passed on to the participants. If such rates change prior to departure, *Anderson Tours* is not under any obligation to pay extra expenses arriving from unforeseen circumstances, such as a change of itinerary or means of transportation, etc. Extra charges are at the client's expense and will require immediate settlement. Early reservations are strongly recommended, and a deposit of \$500 per person is required at the time of booking, with the remaining balance due 60 days prior to departure. Applications received after this date should include full payment and might be subject to a \$100 late registration fee. Any payments made 30 days prior to departure must be in the form of a cashier's check or money order. Final documents (including airline tickets) cannot be sent until final payment is received. Checks should be made payable to *Anderson Tours*. All cancellation penalties are the responsibility of the participant and those made after full payment is received could incur any airline or other fees and be up to 100% of total program price.

Anderson Tours reserves the right to make changes or substitutions in the interest of the program in order to meet unexpected situations, such as increases in fares and accommodation rates, airline failures, changes in currency rates, etc. prior to departure. Additional charges or refunds will be made to participants where applicable. However, no refund will be made for accommodations or services, included in the price, which are not utilized during the program by the participant. We reserve the right to cancel the program, if deemed necessary for reasons including insufficient program participation and circumstances beyond *Anderson Tours'* control, such as strikes, lockouts, riots, wars, whether declared or undeclared, civil disturbances, acts of God, acts of government or other authorities, thefts, pilferage, epidemics, quarantines, custom regulations, delays, or cancellations of or changes in itinerary or schedules or from any causes beyond *Anderson Tours* control. In such event, *Anderson Tours* shall have no responsibility, beyond the refund of deposits and monies paid to *Anderson Tours* by the participants. A refund will then be made to participants, within 30 days, by means of a company or bank check.
